Q: WHERE IS MONATions UNITED 2026 BEING HELD?

A: MONATions United 2026 will be held in Las Vegas, Nevada.

Q: WHEN IS MONATions UNITED 2026?

A: The conference will take place August 20–23, 2026.

Q: WHAT IS THE PRICE OF REGISTRATION?

A: The cost for MONATions United 2026 registration per person is:

- **MONATions 2025 Attendees Only:** August 23, 2025, 12:00 p.m. PDT – August 24, 2025, 12:00 p.m. PDT: \$109 USD + tax
- **3-Day Pre-Sale:** August 24, 2025, 12:00 p.m. PDT – August 27, 2025, 11:59 p.m. EDT: \$119 USD + tax
- August 28, 2025, 12:00 a.m. EDT – December 1, 2025, 11:59 p.m. EDT: \$199 USD + tax
- December 2, 2025, 12:00 a.m. EDT – June 22, 2026, 5:00 p.m. EDT: \$249 USD + tax
- June 22, 2026, 5:01 p.m. EDT – August 20, 2026, or sell out: \$289 USD + tax

Q: CAN I BUY MULTIPLE REGISTRATIONS?

A: The presale 10-pack bundles offered at the MU25 Attendee-Only 24-Hour Pre-Sale (August 23–24, 2025) and the MU26 Market Partner 3-Day Pre-Sale (August 24–27, 2025) can only be purchased by active Market Partners and must be purchased in a single transaction with one form of payment. Presale bundle purchases and individual presale registrations are non-refundable, non-transferable, have no cash value, and must be redeemed by Wednesday, June 10, 2026, at 5:00 PM EDT. Any unused codes after this deadline will expire and be forfeited. No name changes are permitted. Registrations or unused presale codes cannot be reassigned, resold, transferred, or used by anyone other than the original registrant.

Q: HOW DO I REGISTER FOR MONATions UNITED 2026?

A: To register, visit MONATions.com.

Q: WHAT IS INCLUDED IN THE REGISTRATION FEE?

A: Your registration fee includes admission to general sessions on Friday and Saturday, and the Dream Bigger Celebration closing event on Saturday.

Q: WHO MAY ATTEND MONATions UNITED 2026?

A: To enter all sessions, you must be a paid registrant with an officially issued badge provided at registration onsite. Minimum age requirements by event type are as follows:

- General Sessions on Friday and Saturday: 12 years or older by the event date.
- Evening Events: 12 years or older by the event date, unless otherwise specified.

Q: DOES MY IN-PERSON REGISTRATION INCLUDE HOTEL, AIRFARE, OR MEALS?

A: No. Hotel accommodations and airfare must be booked and paid for by the participating registrant and are not covered by the registration fee. Discounted lodging information will be available at MONATions.com.

Q: MAY I BRING MY CHILD?

A:

- Nursing infants 24 months or younger may attend with their registered parent at no additional cost. However, nursing mothers and infants may be asked to relocate to the dedicated onsite suite should their infants affect the ability of other attendees to hear the event without disruption.

Clark County Childcare Regulations prohibit the Hotel from offering childcare services on the premises.

Providing childcare services at the Hotel is unlawful and management will disband any childcare activity discovered on the premises.

- Attendees must be at least 12 years of age to attend all training and general sessions. Regardless of age, other than nursing infants, all attendees must be fully paid registrants with a badge to enter the sessions. Attendees with infants 24 months or younger may consider bringing ear protection due to the volume of the event.

Q: MAY MY SPOUSE OR GUEST ATTEND?

A: Certainly! Spouses should register separately to receive their own badge for access to all sessions. Spouse or guest attendance is not included with Market Partner registration at MONATions United 2026. Your Market Partner ID cannot be used to register your spouse or guest.

Q: MAY I REGISTER TO ATTEND THE EVENING EVENTS ONLY?

A: No. Evening event attendance is limited to fully registered badge holders only. Evening event attendance cannot be purchased separately.

Q: MAY I REQUEST A REFUND?

A: MONATions 2026 registrations sold at a discounted rate between August 23, 2025, 12:00 p.m. PDT – August 24, 2025, 12:00 p.m. PDT, and the presale + 10-pack bundle registrations sold at discounted rates between August 24, 2025– August 27, 2025, 11:59 p.m. EDT are **non-refundable** and **non-transferable**. Standard registrations purchased by individuals, and unrelated to presale discount registrations, are refundable through Tuesday, May 12, 2026.

Multiple registration presale bundle purchases AND individual presale registrations are non-refundable, non-transferable, have no cash value, and must be redeemed by Wednesday, June 10, 2026, at 12:00 p.m. EDT. Any unused pre-sale code quantity remaining after Wednesday, June 10, 2026, at 12:00 p.m. EDT will expire, and the value considered forfeited.

Q: MAY I CHANGE THE NAME ON MY REGISTRATION?

A: NO NAME CHANGES are permitted on any registration.

Q: WILL THERE BE TRANSLATIONS AND ASL INTERPRETATION PROVIDED FOR THIS EVENT?

A: Yes, we will provide Spanish, French, Polish, Lithuanian, and American Sign Language (ASL). MONAT Events are intended to be fully compliant with all ADA guidelines. Make sure to add any special accommodations during your registration process.

Q: HOW CAN I GET AROUND LAS VEGAS DURING THE EVENT?

A: Taxis, Ubers, Lyfts, and other Rideshares are readily available throughout Las Vegas at your own expense.

Q: WHAT ARE YOUR SAFETY PROTOCOLS?

A: MONAT Global will adhere to all federal, state, and local authority guidance, as well as any venue or location-specific regulations.

Q: WHAT SHOULD I WEAR?

A: We recommend business casual attire for the event. Event spaces may be chilly, so plan accordingly. More details on special event attire will be shared closer to the event date.

Q: IF I DO NOT ATTEND THE EVENT, OR MISS PICKING UP MY SWAG BAG FOR ANY REASON, WILL I BE ELIGIBLE TO HAVE THE SWAG BAG SENT TO ME?

A: No, you will not be able to receive the swag bag if you do not attend the event or if you miss pickup.

Q: MAY I PURCHASE THE SWAG BAG?

A: No, the swag bag is not available for purchase.
