TERMS AND CONDITIONS

August 23, 2025

These terms and conditions govern your participation in MONATions event (hereinafter, "MONATions United 2026") taking place on August 20–23, 2026 in Las Vegas, Nevada. By registering for MONATions United 2026, you agree to these terms and conditions, which form a binding legal agreement between MONAT Global Corp. ("MONAT"), and the registered participant ("You" or "Participant"). If you are registering on behalf of another individual, it is your responsibility to ensure that the person participating is aware of these terms and conditions and accepts them. By completing the registration on behalf of another individual, you are representing and warranting that you have made the Participant aware of these terms and conditions and that they have accepted these terms and conditions.

By completing this registration for MONATions United 2026, you represent and warrant that either (i) you are a MONAT Market Partner in good standing with the company, and will remain in such good standing at all times during MONATions United 2026 in order to remain eligible to attend, or (ii) you have never been a MONAT Market Partner and have never been terminated from a Market Partner agreement prior to registration for MONATions United 2026. Further, by registering for MONATions United 2026, you represent and warrant that you are not a plaintiff, member of any class action or party to any litigation in current, pending, or settled case against MONAT Global Corp., its parent, Alcora Corporation, or any of its affiliates or subsidiaries.
