

TERMS & CONDITIONS

- All pre-purchased tickets are non-refundable as of August 1, 2020. Single pre-purchased tickets must have named attendees by April 30, 2021. Complete “unnamed” attendees at monations.com and click the button “redeem your voucher code.” Unnamed tickets after April 30, 2021, have no value, are non-transferable, and no refund will be provided. Photo IDs will be required at 2021 badge pickup matching the legal first and last name under which the ticket is registered. Pre-sale tickets continue to be non-transferable when picking up on-site.
- Standard ticket purchase (not pre-sale) is refundable but subject to a 10% cancellation fee if canceled by July 31, 2021.
- I agree that MONAT reserves the right to modify trip dates, inclusions, or program specifics at any time, and may even cancel the trip for any reason beyond the reasonable control of MONAT or the destination hotel for the trip, including but not limited to “Acts of God,” civil unrest, war, transportation disruption, weather, or national emergency, epidemic, pandemic, labor strikes or any other circumstance that MONAT or the destination hotel, in their sole discretion, deem as making this trip impracticable, impossible or unsafe.
