

TERMS & CONDITIONS

- All pre-purchased tickets are non-refundable as of 1st August 2020. Single pre-purchased tickets must have named attendees by 30th April 2021. Complete “unnamed” attendees at monations.com and click the button “redeem your voucher code.” Unnamed tickets after 30th April 2021, have no value, are non-transferable, and no refund will be provided. Photo IDs will be required at 2021 badge pickup matching the legal first and last name under which the ticket is registered. Pre-sale tickets continue to be non-transferable when picking up on-site.
- Standard ticket purchase (not pre-sale) is refundable but subject to a 10% cancellation fee if cancelled by 31st July 2021..
