## **TERMS AND CONDITIONS**

April 22, 2026

These terms and conditions govern your participation in MONATions: The World Tour events (hereinafter, "MONATions") taking place in the months of September & October 2026 in Anaheim, CA, Orlando, FL, Mexico City, Mexico, Sydney, Australia and Europe. By registering for MONATions 2026, you agree to these terms and conditions, which form a binding legal agreement between MONAT Global Corp., MONAT Global Mexico (operating under MONATURE, S. de R.L. de C.V.), (operating under MONAT Natural Europe Limited), MONAT Global France SAS, MONAT Global Italy S.r.l., MONAT Global Poland sp. z o.o., ul., MONAT Global Spain, S.L., MONAT Global Australia PTY LTD (collectively, "MONAT" or the "Company"), and the registered participant ("you" or "Participant"). If you are registering on behalf of another individual, it is your responsibility to ensure that the Participant is aware of these terms and conditions and accepts them. By completing the registration on behalf of another individual, you represent and warrant that you have made the Participant aware of these terms and conditions and that they have accepted these terms and conditions.

By completing this registration for MONATions, you represent and warrant that either (i) you are a MONAT Market Partner in good standing with the company, and will remain in such good standing at all times during MONATions in order to remain eligible to attend, or (ii) you have never been a MONAT Market Partner and have never been terminated from a Market Partner agreement prior to registration for MONATions. Further, by registering for MONATions, you represent and warrant that you are not a plaintiff, member of any class action or party to any litigation in current, pending, or settled case against MONAT Global Corp., its parent, Alcora Corporation, or any of its affiliates or subsidiaries.

### **REFUNDS AND TRANSFERS**

MONATions registrations sold at a discounted rate between April 22, 5:00 p.m.–April 24, 11:59 p.m. EDT 2026 are non-refundable. Early birds sold at discounted rates between April 25, 12:00 a.m.–June 30, 11:59 p.m. EDT 2026 and standard tickets from July 1, 12:00 a.m. EDT 2026 through the event date are refundable only up to 60 days before the respective event start date.

NO NAME CHANGES are permitted. Registered attendees who are unable to attend for any reason will forfeit the value of the registration. MONAT Global Corp. assumes no responsibility for loss or unintended use or misuse of presale codes. Presale codes are the equivalent of cash and will not be replaced or refunded if lost or misused.

## FORCE MAJEURE

In no event shall MONAT be considered in default in performance of its obligations arising out of or caused by, directly or indirectly, forces beyond its control, including, without limitation, hostilities, civil commotion or riots; strike or lockout; epidemic, pandemic, norovirus, accident, fire, flood, earthquake, windstorm or explosion; lack of or failure of transportation facilities; lack of or failure of power facilities, regulation, ordinance, or requirement by any government or governmental agency having or claiming to have jurisdiction over events; or any act of God or of government; or any cause, existing or future, which is beyond the reasonable control and without the fault or negligence of the parties. MONAT shall not be obligated to reschedule MONATions or provide separate or additional compensation of any kind.

Hotel bookings and cancellations are the responsibility of the Market Partner or Guest and are not connected to registration cancellation. Airline, hotel, and affiliated cancellation policies are not the responsibility of MONAT Global Corp., its parent company, Alcora Corporation, or any of its affiliates or subsidiaries.

## PROHIBITED CONDUCT

1. **Disruptive Conduct.** You acknowledge and agree that MONAT reserves the right to remove you from the MONATions event if MONAT, in its sole discretion, determines that your participation or behavior creates a disruption or hinders the event or the enjoyment of the event by other attendees.

2. **Unethical/Non-Compliant Business Practices.** MONAT reserves the right to deny participation to anyone who engages in, or is reputed to engage in, unethical or non-compliant business practices.

In addition to the requirements and prohibitions set forth in this section above, MONAT may also exclude any person from registering for or participating in the MONATions 2026 events, at MONAT's sole and exclusive discretion.

## RELEASE; INDEMNIFICATION; LIMITATION OF LIABILITY; DISCLAIMER OF WARRANTIES

As a result of the Market Partner's and/or Guest's participation in MONATions, the Market Partner or Guest(s) (hereinafter, "Market Partner" or "Guest(s)") agree to indemnify, defend, hold harmless MONAT and any of its officers, officials, agents, employees, or affiliated companies (hereinafter, "Indemnitee") from and against any and all claims, costs, obligations, losses, or lawsuits of any nature or kind, including reasonable court costs, attorneys' fees, and other defense costs, arising out of or from any conduct, negligence, or failure to act by MONAT in any way connected to MONATions. The Market Partner and/or Guest(s) acknowledge that MONAT is not responsible for errors, omissions, acts, or failures to act of any party or entity conducting a specific activity on its behalf.

## **GOVERNING LAW**

These terms and conditions shall be constructed pursuant to and governed by the substantive laws of the State of Florida without regard to its conflicts of laws principles for MONATions events held in the United States. For MONATions events held in Mexico City, Mexico, Sydney, Australia, and Europe, the respective laws of the jurisdictions in which the event takes place and at which Participant attends will govern the interpretation and application of these Terms & Conditions.

## **JURISDICTION**

For MONATions events held in the United States, Market Partner and/or Guests hereby consent to the non-exclusive jurisdiction of any State or Federal Court of competent jurisdiction located within Miami-Dade County, Florida, in connection with any actions or proceedings arising directly or indirectly from these terms and conditions.

## **CHANGES TO THESE TERMS**

The Company may make amendments to the provisions of these terms from time to time. Any amendments will be notified to you by being posted on our website. It is your responsibility to refer regularly to these terms and note any amendments. Amendments will come into effect immediately on the amended terms being posted on the MONAT website and you will be deemed to have accepted them if you access the website after that time.
